Communicating and consulting over the next year

We have been working hard on Chartered Archaeologist since the AGM last November where members voted, after considerable debate, to continue work to take forward proposals which had been laid before the meeting.

As the proposals develop further, we will be continuing to consult and debate in order to achieve a situation where we have given members every opportunity to ask questions, make suggestions, and shape developments.

The timetable below sets out our current aspirations for progress towards a final vote on a formal Chartered Archaeologist proposal:

We are looking forward to opportunities for informal debate at Conference 2018 as well as wider consultations and feedback opportunities on detailed aspects of the plan, leading to a formal consultation on a draft proposal in early 2019.

We also wish to explore concerns with the basic proposed model of individual charter, outlined in the draft proposals, on an ongoing basis. And we accept that if there are significant challenges which remain to be solved, that this timetable can be extended to allow for more consultation and changes to the proposals. We will be instituting a system to allow all members to vote on the proposals, without having to attend the meeting.

We are confident that the proposals set out a model for individual chartership which fits the requirements of the archaeological profession and that Chartered Archaeologist will be a new mark of professionalism in the sector, which will be instantly recognised outside the profession. Progress towards designing the details will ensure that it will be both rigourous in assessing competence and also accessible to a wide range of archaeologists from across the sector who are committed to advancing their career in archaeology."
